

**VOLUNTARY BOUNDARY ADJUSTMENT
AGREEMENT**

This Voluntary Boundary Adjustment Agreement ("Agreement") is made and entered into this _____ day of _____ 2024, by and between the TOWN OF ROCKY MOUNT, VIRGINIA, a political subdivision and an independent town of the Commonwealth of Virginia with powers vested in its Town Council ("Rocky Mount" or "Town"), and FRANKLIN COUNTY, VIRGINIA a political subdivision of the Commonwealth of Virginia with powers vested in its Board of Supervisors ("Franklin County" or "County").

WHEREAS, Rocky Mount owns approximately 20 acres more or less in Franklin County that it plans to develop;

WHEREAS, Franklin County recognizes that some parcels located in Franklin County receive utility services from Rocky Mount, and others have transportation needs that would be better served within the boundaries of the Town;

WHEREAS, the Town and Franklin County, in recognition of the benefits that the boundary adjustment would confer upon the residents of both the Town and the County, desire to facilitate and effectuate this adjustment, through mutual agreement, by making certain changes to the boundary lines between Rocky Mount and the County;

WHEREAS, Franklin County, acting under the authority of its Board of Supervisors, has approved this Agreement and authorized the undersigned official representatives to execute the Agreement on behalf of Franklin County; and,

WHEREAS, Rocky Mount, acting under the authority of its Town Council, has approved this Agreement and authorized the undersigned official representatives to execute the Agreement on behalf of Rocky Mount;

NOW THEREFORE, in consideration of \$10.00 and intending to be legally bound, Rocky Mount and Franklin County (each a "Party" and collectively referred to as the "Parties") agree as follows:

Boundary Adjustment.

- a. The Parties shall take all necessary, legally permissible action to cause the entirety of each of the parcels identified in Appendix A attached hereto, and shown on the map identified as Appendix B attached hereto, to be legally removed from within the boundaries and under the jurisdiction of Franklin County and included within the boundaries and under the jurisdiction of Rocky Mount.
- b. General Procedure to Effect the Boundary Adjustments.

- (i) The Parties covenant that they will take all necessary and reasonable action to implement the terms of this Agreement in accordance with the requirements for voluntary settlements among local governments set forth in Va. Code § 15.2-3106.
- (ii) This Agreement shall constitute an agreement pursuant to Va. Code § 15.2-3106.
- (iii) The parties will advertise their intent to adopt this Agreement in accordance with Va. Code § 15.2-3107.
- (iv) Rocky Mount and Franklin County shall petition the Circuit Court of Franklin County for approval of this agreement in accordance with Va. Code § 15.2-3108.
- (v) The boundary adjustment will become effective upon entry of an appropriate order by the Circuit Court of Franklin County.

Miscellaneous.

a. Entire Agreement.

This Agreement constitutes the entire agreement between the Parties concerning the voluntary boundary adjustments described in Section 1.1 and supersedes all prior oral or written agreements, understandings, representations and warranties, and courses of conduct and dealing between the Parties with respect to any of the parcels described in Appendices A and B.

b. Amendment.

This Agreement may be amended or modified only by a writing executed by both of the Parties.

c. Extension or Waiver of Performance.

Each Party may extend the time for or waive the performance of any of the obligations of the other, waive any inaccuracies in the warranties or representations made by the other, or waive compliance by the other with any of the covenants, conditions or agreements contained in this Agreement, provided that any such extension or waiver shall be in writing and signed by the waiving Party in the case of a waiver, or each of the Parties in the case of an extension.

d. Assignment or Delegation.

No Party shall assign, delegate or otherwise transfer any of its duties, rights or

obligations under this Agreement without the prior written consent of the other Party.

e. Successors and Assigns; Binding Effect.

This Agreement shall be binding upon, and inure to the benefit of the Parties and their respective successors and permitted assigns.

f. Governing Law.

This Agreement shall be governed by and construed under the laws of the Commonwealth of Virginia.

g. Notices.

All notices provided for in this Agreement shall be in writing, addressed to Rocky Mount or Franklin County, as the case may be, at the addresses set forth in this Paragraph and may be (a) delivered in person; (b) sent by United States registered or certified mail, return receipt requested; or (c) sent by Federal Express or any other nationally recognized overnight courier or delivery service from which a receipt may be obtained.

Each Party shall have the right to designate for itself a new recipient and/or address for the receipt of notices by written notice to the other Party.

h. Captions.

The headings and captions used with the subsections, sections and articles of this Agreement are for convenience or reference only and shall not be deemed to modify or limit the provisions of this Agreement.

i. Construction.

In the event any ambiguity or question of intent or interpretation arises, this Agreement shall be construed as if drafted jointly by the Parties, and no presumption or burden of proof shall arise favoring or disfavoring any Party by virtue of the authorship of any of the provisions of this Agreement.

Any reference to any federal, state, local or foreign statute shall be deemed to refer to all statutes, rules and regulations referenced therein or promulgated thereunder, unless the context requires otherwise.

Words used herein, regardless of the number and gender specifically used, shall be deemed and construed to include any other number, singular or plural, and any other gender, masculine, feminine or neuter, as the context may require. The word "including" means included, without limitation.

j. Cumulative Remedies.

The remedies afforded in this Agreement are cumulative to each other and to all other remedies provided by law.

k. No Waiver.

Except as otherwise provided herein, no delay of or omission in the exercise of any right, power or remedy accruing to any Party as a result of any breach or default by any other Party under this Agreement shall impair any such right, power or remedy; nor shall it be construed as a waiver of or acquiescence in any such breach or default, or any similar breach or default occurring later; nor shall any waiver of a single breach or default be deemed a waiver of any other breach or default occurring before or after that waiver.

l. Time of the Essence.

Time is of the essence in the execution and performance of this Agreement.

m. Third Party Beneficiaries.

Nothing herein expressed or implied is intended or should be construed to confer upon or give to any person (other than the Parties) any rights or remedies under or by reason of this Agreement.

n. Counterparts.

This Agreement may be executed in one or more counterparts, each of which shall be deemed to be an original copy of this Agreement and all of which, when taken together, shall be deemed to constitute one and the same agreement.


