**PUBLIC NOTICE OF HEARINGS TO CONSIDER AN AGREEMENT  
BETWEEN THE TOWN AND COUNTY TO ADJUST LOCATION OF THE  
BOUNDARY LINE BETWEEN THE LOCALITIES**

The Franklin County Board of Supervisors and the Rocky Mount Town Council give notice of their intent to enter into an agreement to adjust the boundary line between them. The proposed boundary adjustment is described as various properties along Diamond Avenue Extension, Highland Hills Road, Circle View Street, Shameka Lane, Friendly Street, Emerald Lane, Ruby Lane, Powerline Road, Greens Park Drive, Sycamore Street, Compton Street, Mountain Top Drive, Greenview Drive, Creekwood Drive, Dillard Lane, Forest Hill Lane, Belmont Drive, and Scuffling Hill Road. Also included is parcel 0630025400 owned by the Economic Development Authority of the Town of Rocky Mount. The proposed boundary adjustment would potentially incorporate approximately 591 acres, based on GIS records, from within the boundaries of Franklin County into the Town of Rocky Mount, Virginia.
